Description and learning objectives: The course is designed to provide students with a background in macroe-conomic theory at intermediate level. After completing this course, the student will be able to: (1) understand methods to measure macroeconomic indicators and empirical regularities; (2) apply macroeconomic models to understand macroeconomic phenomena; (3) apply macroeconomic models to evaluate government policies; (4) develop deeper preparation for reading economic press and more advanced literature; (5) formulate a well-organized economic argument and communicate it effectively in written form.

Reading materials: I will upload lecture notes/slides, syllabus, homeworks, and solutions on Blackboard. The lectures notes will be based on

Williamson, Stephen. 2014. Macroeconomics (5th edition), Addison Wesley (ISBN-10: 0132991330). [SW][Required]

The idea is that you print lecture slides off and bring them to class. Students are expected to have completed the readings prior to lecture. The lectures, classroom activities, and all materials associated with this class and developed by the instructor are copyrighted in the name of Roberto E. Duncan on this date (8/22/2022).

Exams: There will be three exams. The use of notes, books, calculators, cellphones, or any other similar material or device is not allowed during any exam. The transgression of this rule is considered academic misconduct (more on this below). The first midterm exam is on September 28 during class time. The second midterm exam is on November 9 during class time. Please arrive ten minutes early to the assigned classrooms. Make-up exams will be given only under exceptional circumstances. Notice must be given before the date of the exam (as early as possible). If there is a make-up, this might be a cumulative oral exam and might be scheduled at the end of the quarter. The (noncumulative) final exam is on Wednesday, December 7, at 12:20 p.m.

Homeworks: Homeworks will be due every week or so at the beginning of lecture. Only electronic copies are accepted. Include your first and last names and section number on the top of the first page. There is a late-homework policy. Late homeworks will be accepted for partial credit, but only up to two days after the due date. Every day the penalty will be 15%. If, for example, you turn it in a few minutes later or up to 24 hours later than the due date and time, then your maximum score will be computed over 85% of the original total points. If you are going to turn in any homework after the due date you must coordinate by email with me and give it to me in my office (do not use any mailbox). The late homework policy does not apply if a student turns in partial answers in two or three days (e.g., half of the homework one day and the remaining the next one). You are allowed and encouraged to discuss course material including homeworks with other students in class or in groups. However, you, not your group, must turn in the solution to each homework problem. If you solve a homework with a classmate or group, you must cite that on the front of your homework. The transgression of this rule is considered academic misconduct. Electronic copies of handwritten solutions are accepted. Just be sure that they are legible, neat, and organized, otherwise you might lose points. Do not forget to show your work.

Grading: The course grade will be based on (i) the simple average of the three exams and (ii) the average of homeworks. The exams will be worth 75% and the homeworks will count for 25%. That is, Score=0.25×(Midterm Exam 1)+0.25×(Midterm Exam 2)+0.25×(Final Exam)+0.25×(Average of Homeworks). Once your course score is computed, your course grade will be determined. Grades will depend on the overall performance of the whole class. There is not a fixed scale to assign grades such as 80%-89% is a B. Based on previous semesters, the median grade of my courses has been a B- or B and students required at least 50% of the score of the student with the maximum score in the course in order to get a passing grade (that is, D- or better). There is a regrading policy. You can request regrading of any homework or exam during a limited period (one week).

Attendance and office hours: Attendance is highly recommendable and class participation can be also part of

your final grade. Every week I will ask questions in class randomly. If the chosen student responds correctly, that will count for the next homework or exam score. On the other hand, you are responsible for any announcement, reading material, homeworks, etc., mentioned, covered, or assigned in class. If you miss a class, it is your responsibility to get notes and other relevant information from your classmates. The use of electronic devices aside from those used to have remote classes (tablets, smartphones, etc.) during a (online or on-site) lecture is not recommended. It is worth mentioning that office hours do not replace a lecture for a student who missed a class. The objective of office hours is to solve specific doubts and questions about the topics and concepts addressed in lectures. Again, feel free to use my office hours and arrange an appointment by email.
